(1) Includes the sales from Walmart U.S. and Sam's Club stores and clubs open for the previous twelve months, including remodels, relocations, expansions and conversions, as well as eCommerce sales. We measure the eCommerce sales impact by including all sales initiated digitally, including omni-channel transactions fulfilled through our stores and clubs. Sales at a store that has changed in format are excluded from comparable sales when the conversion is accompanied by a relocation or expansion that results in a change in square footage of more than five percent. Sales related to divested businesses are excluded from comparable sales, and sales related to acquisitions are excluded until such acquisitions have been owned for 12 months.
