The price reported above reflects the weighted average sale price. 2. The transaction is a distribution of 1,258,000 shares of Common Stock, for no consideration, by the Trust to beneficiaries of the Trust.

3. This sale from the Trust was executed in multiple trades at prices ranging from \$58.33 to \$58.80, inclusive. The price reported above reflects the weighted average sale price. 4. The reporting person is a trustee of the Trust, the entity that owns 653,067,261 shares of Common Stock. The reporting person disclaims beneficial ownership of the reported securities held by the Trust except to the extent of his pecuniary interest therein.

5. The reporting person is a member of Walton Enterprises, LLC, the entity that owns 3,002,673,393 shares of Common Stock. The reporting person disclaims beneficial ownership of the reported securities held by such LLC except to the extent of his pecuniary interest therein.
